



## FLYING IN MOZAMBIQUE

Do not fly into Mozambique without a Clearance. Make sure you know all the regulations.

Always question landing and navigation fees. As guidelines, the official Fees are given on the following pages. Check also the availability of Avgas at airfields beforehand. This can change within days. Payment for navigation-, landing- and parking fees as well as for fuel, is only accepted in US \$ or ZAR. Ensure that you carry enough small bills - you will not get any change. General: only drink bottled Water. Do not eat seafood inland. VISA required if crew stays for more than 1 night

### FLYING IN ZAMBIA

When flying to camps in the Western sector, i.e. Hippo, Chunga, Moshi - fly to waypoint Muwezwa (S15 27.13 E026 48.21 - RAD 271 LV). Set course from that point to your destination as long as you cross the Mumbwa tar road at 5000' ALT to below.

Private airstrips that are not tarred: Check beforehand with DCA which strips are open, as all strips are officially closed after 31 December each year and have to be inspected by DCA before re-opening.

Landing fees are only accepted in US \$ or ZAR. For fuel, Zambian Kwacha are also accepted.

All a/c prohibited from using AF owned by Ministry of Defense. A/c wishing to use military airfields are required to obtain written permission prior to flight from the Ministry of Defense Tel. (Harare) 04-700155.  
Do NOT land at any Military strip - there's a good chance you get locked up.

Do not attempt to fly into Zimbabwe without prior permission at least 24hrs in advance.


